## **GENERAL TERMS & CONDITIONS**

Other terms and conditions applicable to all visitors to APBS and/or its Brewery Tour are listed below. By entering our premises, visitors agree to comply with these terms and conditions.

- 1. The public may embark on our Tour on such days and at such hours as prescribed by APBS on notices displayed at the brewery or on its website(s) and other collaterals. APBS may, in its absolute discretion, vary the operation hours without prior notice.
- 2. APBS may, in its absolute discretion
  - require visitors to produce identification and/or give up their personal particulars in which case each visitor warrants to APBS that such particulars are true and accurate; and
  - refuse sale of admission and/or demand any visitor to leave its premises. In such circumstance, APBS may at its discretion and without prejudice to its rights, elect to refund the cost of the admission if any.
- 3. Visitors to APBS' premises
  - may not use or reproduce photographs/recordings taken at authorized areas for commercial purposes and agree to remove or surrender any such media to APBS and/or upon APBS' request; and
  - consent to APBS taking photographs or other media recordings of their person and waive any rights at law in respect of the same. APBS shall own all such photographs/recordings and APBS may therefore use the same at its discretion (including commercial purposes) without charge.
- 4. APBS reserves the right to amend these terms and conditions at its absolute discretion without prior notice including but not limited to varying its opening hours, admission, car park and/or any other applicable charges without prior notice.
- 5. APBS shall not be liable (to the extent permitted by law) for any claim, injury, loss, damage or inconvenience arising out of or in connection with howsoever caused to or sustained by any visitors to its premises including but not limited to any loss arising from or in connection with any delay, cancellation or closure of the premises or Tour or any show, exhibits or feature thereto whether resulting from acts or occurrences beyond its control (such acts of God, government regulations or authority, war or national emergency, accident, fire, strikes, disturbance or industrial disputes or outbreak of disease).

APBS may at its discretion, provide medical or other form of assistance on a goodwill basis. In no event shall the provision of such assistance amount to or be construed as an admission of liability by APBS.

In any event, any liability on APBS' part shall be limited to the cost of admission if any.

- 7. The Contracts (Rights of Third Parties) Act CAP 53B of the statutes of the Republic of Singapore is expressly precluded from application to these terms and conditions.
- 8. This Agreement is governed by Singapore law and parties agree to submit to the non-exclusive jurisdiction of the courts of the Republic of Singapore.
